


RULES & REGULATIONS OF ALLIANZ PACER RUN 2017


1. The **ALLIANZ PACER RUN 2017** ("the Event") is organised by **FAT BOYS Sdn. Bhd.** ("the Organiser") and in accordance with the **ALLIANZ PACER RUN 2017** Rules & Regulation.


2. ORGANISER RIGHTS

- 2.1 By signing up for and provide any information, personal or otherwise, to have access to any product (s) and / or service (s) and / or participating in any program (s), event (s), talk (s), demonstration (s) or any other activity involving the organizers and sponsors of the event ("sponsors"), individual ("Participants") are deemed to have given explicit permission to the organizers and sponsors to collect, analyze, collect , share, disclose to third parties, sell and / or otherwise use without any liability to the individual, any personal information relating to individual discretion deems appropriate, including but not limited to the programs, plans, data - processing and statistics or risk analysis, research, fundraising and / or any other purpose in performing those functions. Organisers and sponsors of the event is declared as an owner or a sponsor, they can use third-party services.
 - 2.1.1 For the development or implementation of programs, products or services that are deemed necessary;
 - 2.1.2 For the outsourcing of any program (s), event (s), talk (s), demonstration (s) and / or any activity;
 - 2.1.3 For administrative purposes the promotion, marketing and / or;
 - 2.1.4 For all purposes as required by law, including without limitation, court proceedings, criminal investigation or prosecution or if so ordered by any competent authority;
 - 2.1.5 With regard to any proposed novation, assignment, transfer, sale, lease, license, partnership, co-organizer and / or any co-operation where and when necessary in relation thereto.
- 2.2 By signing up for the Event, the Participant agrees that the Organiser might post the full race results on the website after the race.
- 2.3 The Organiser reserves the right to modify or replace any of the Terms and Conditions of this event from time to time as it deems fit. If there is ambiguity in any provision, the Organiser shall be authorized to interpret and in doing so, the organizers will take into account the interests of all participants involved. Any update on the Rules and Regulations The event will be at the official event registration portal and is the responsibility of the affected participants to keep abreast of any changes.
- 2.4 The Organiser reserves the right to cancel or postpone the event at any time without prior notice to Participants, where the organizers will endeavor to inform the participants before the event. If the event should be canceled or postponed, there will be no refund of fees or donations paid unless the organizers deem fit to provide refund and Organiser will not be held liable for any loss or inconvenience caused.
- 2.5 The Organiser reserves the right to amend the race route it thinks fit for the safety of participants and / or to avoid any danger that might arise in the running of the event, at any time without prior notice to Participants. In such cases, every effort will be made to inform participants before the event date. Organiser will not be held liable for any loss or inconvenience caused by the change.

- 2.6** If the original participant's bib number is missing or not available at all Race Pack Collection, the Organiser reserves the right to replace it with a spare bib number. The Organiser reserves the right to amend or replace any bib participants walk at any time without prior notice to Participants.
- 2.7** The Organiser reserves the right to use any images (including a Participant), motion pictures, recordings, or any record of another media event, for any lawful purpose, including commercial advertising and distribution to the Sponsor any anywhere in the world.
- 2.8** The Organiser reserves the right to limit and/or refuse entry to the Event and/or other programs(s), event(s), talk(s), demonstration(s) or any other activities involving the Organiser and the Event sponsors without giving any reason and/or notice.
- 2.9** The Organiser shall not be liable for any loss and/or damage to, personal or otherwise, to property and goods that are stored in the luggage storage is available for runners. Organisers also reserve the right to inspect any goods or luggage deposited.

3. PARTICIPANT RESPONSIBILITY.

- 3.1** Participants hereby agree to release and hold the Organizer, FAT BOYS OF RECORDS SDN. BHD. and ALLIANZ MALAYSIA BERHAD, officers, directors, agents, employees, property owners, trainers and allies and from and against any liability, all sorts of actions and causes of action, judgments, executions, debts, claims and demands of every kind and nature arising from any loss, injury, damage, death caused to property or any other person arising from or in connection with participation in the event either loss injury, damage, death caused directly or indirectly by the negligence, breach of contract or in any way arising from exercise to, during, or after participation in the event.
- 3.2** The Participant also certifies and declare that the Participant is not at present under any form of medical treatment for physical infirmity, chronic illness, or mental disorder that could affect participation in the Event. Participants are also strongly encouraged to go for a medical examination and/or consult their medical practitioner prior to registration and before the actual Event Day.
- 3.3** Completion of the official entry form, including online registration, confirms the Participant's agreement to abide by all the relevant Rules and Regulations of the Allianz Pacer Run 2017, Organiser, and Sponsors.
- 3.4** Registration for the race only confirmed after payment is made and after the grant of the identification number.
- 3.5** In consideration of the participants using the site of the event, participants agreed to;
- 3.5.1** Provide true, accurate, current and complete information contained in any registration form (such information as "Registration Data")
- 3.5.2** Maintaining the security of the password and identity.
- 3.5.3** Maintain and update the Registration Data to keep it true, accurate, current and complete. Organisers may contact the Participant from time to time via e-mail. Any notice sent to the email address registered with the organisers shall be deemed accepted by the Parties. If the Participant to provide any information that is untrue, inaccurate, outdated or incomplete, or the Organizer has reason to suspect that such information is untrue, inaccurate, outdated or incomplete, the Promoter may suspend or terminate their registration and refuse any and all current or future use of the web page event (or any portion thereof).

- 3.6** The Organiser will not entertain and do not in any way responsible for any disputes arising from the inclusion of details that are incomplete or inaccurate information in the registration form.
 - 3.7** The information on the back of the Participants bib must be completed fully and accurately.
 - 3.8** Participants are not allowed to transfer their entry to another race or change the category of the race after their registration is confirmed


4. REFUND

- 4.1** There will be strictly no refunds available if the Event is cancelled for reason of force majeure i.e. due to the occurrence of incidents that are beyond the control of the Organiser or acts of God which render it impossible or unsafe to hold the Event.
- 4.2** Once registration has been duly processed, there will be strictly no refunds of fees for Participants who do not eventually participate in the Event for whatever reason

5. SAFETY

- 5.1** While every reasonable precaution will be taken by the Organiser to ensure the Participants' safety, Participants run solely at their own risk and the Organiser will not be responsible or held liable for any injury or death howsoever arising from training for, during, or after the participation in the Event. Participants are strongly encouraged to go for a medical examination and/or consult their medical practitioner prior to registration and before the actual Event Day.
- 5.2** Partial road closures on the ENTIRE ROUTE will be lifted after three (3) hours from commencement of the race. Cut-off times will be set at specific checkpoints along the route to ensure the safety of runners who are unable to complete the race within the three (3) hours and to ensure that the roads can be re-opened to the public in accordance with the Event permit.
- 5.3** A Participant must retire from the race immediately, if required to do so by any member of the Official, Medical Staff, Race Director, Marshall, and/or Security Officer.
- 5.4** Pets, bicycles, in-line skates, prams, push carts, shoes with built-in or attached rollers and any other wheel-run objects are NOT ALLOWED on the 12km course other than official race and medical vehicles.

6. DISQUALIFICATION

- 6.1** Any Participant who commences running before the actual flag-off of his/her registered race category will be immediately disqualified. (Please refer to individual race category start times).
 - 6.2** Participants who do not start within 15 minutes of respective flag offs i.e.12km and 6km, for safety reasons may not be allowed to start and will be immediately disqualified.
 - 6.3** Participants must wear the assigned bib number visibly on his/her chest at all times. Participants who do not display bib numbers will be taken off the course by security officers/officials and immediately disqualified.

7. ELIGIBILITY

- 7.1** Participants must be 18 years old or older as of Event Day to participate in the 12km Competitive and Competitive Run Category.
- 7.2** Participants must be 16 years old or older as of Event Day to participate in the 6km Fun Run Category.
- 7.3** Corporate Challenge
- 7.3.1** The company must be based in Malaysia to participate in the Corporate Challenge.
- 7.3.2** Team members of Corporate Challenge must be employees from the same company.
- 7.3.3** Each company must register a minimum of five [5] Participants, irrespective of gender.

8. RACE PACK COLLECTION

- 8.1** All Participants must collect their Race Pack which contains their bib number, timing chip (attached to the back of your bib number), event t-shirt, and other sponsored items [If any] during Race Pack Collection (RPC) during the pre-determined period and location as stipulated on the Event's website.
- 8.2** To collect your race pack, you must bring the printout of your confirmation slip and your NRIC/passport. You may appoint a representative to collect your race pack on your behalf. The representative must present the following:
- Printout of your confirmation slip
 - Letter of authorization signed by you
 - Representative's NRIC/passport
 - Photocopy of your NRIC/passport
- 8.3** All Race Packs not collected during RPC stipulated time and date, will be deemed to be unwanted, and the Organiser shall be at liberty to dispose or re-distribute them accordingly.
- 8.4** There will be no mailing option of Race Entry Pack for Participants who register under the Corporate Challenge.

9. TIMING

- 9.1** The "Gun Time" will be used to determine the winners for all categories in the 12km distance.
- 9.2** The "Net Time" will be used to get an overall ranking in all categories.
- 9.3** The Corporate team with the lowest aggregate "Net Time" of the first five [5] finishers will be declared the winner.
- 9.4** In case of a tie in the corporate challenge, the corporate team with the lowest "Net Time" of the slowest runner will determine the winner.
- 9.5** All Participants will be ranked as individuals in the overall 12km rankings.
- 9.6** Every Participant in the Corporate Challenge will be treated as individual runners of the 12km Category and all relevant Rules and Regulations apply.

10. GENERAL RULES

- 10.1** Each Participant is allowed to win only one prize-money award in the category that he/she has registered for.
- 10.2** The Organiser reserves the right to replace any winners if he/she is found to be disqualified.
- 10.3** Prize winners must report to the prize giving zone as stipulated on their winner tag. In case a runner fails to do so, the Organiser may donate the cash prize money to charity.
- 10.4** All prize-winning Participants must present their original identification document (such as Passport or Identity Card) to collect their prize money.
- 10.5** For prize winners or possible prize winners, disputes and appeals must be made in writing within thirty [30] minutes of the published results with a non-refundable protest fee of RM50.00, failing which the Organiser reserves the right not to entertain any disputes or appeals thereafter.
- 10.6** For all other Participants, disputes regarding the results timing must be submitted in writing including electronic mail within three [3] days after the Event Day. The Organiser reserves the right not to entertain any dispute or appeal after 6.00pm on November 1st 2017.
- 10.7** For all disputes, the Organiser's decision is final and no other disputes thereafter will be entertained.
- 10.8** The timing chip is a single-use, disposable device attached to the back of the bib. Participants must wear the assigned bib number visibly on his/her chest. Participants in the competitive categories must make sure that the bib is not covered with a jacket or his/her arms when running over the timing mats,
- 10.9** All Participants who successfully complete the fun run 6km and 12km distance will be awarded a finisher medal upon presentation of their bib number.
- 10.10** All finisher medals and goodie bags must be collected on Event Day and no requests will be entertained thereafter.
- 10.11** All Participants who successfully complete the 12km will be awarded an e-certificate. The e-certificate will be made available on the website www.sportsplits.com on 1st November 2017. This entitlement will not apply to participants who are unable:
- i] to complete the race,
 - ii] are disqualified or
 - iii] do not compete in the race.
- The availability of the e-certificate will only be until end of 2017. There will not be any hardcopy finisher certificate mailed out.
- 10.12** The Organiser reserves the right to publish the start list of the Event which the public may see who has officially entered into the Event.
